1. ANBC JUDGES EXAMINATION PANEL. Russel Keane advises that Nigel Tonkin (B.C.S.A.) has been appointed to the A.N.B.C. Judges Examination Panel to fill the vacancy which was due to the resignation of Len Vinci.
2. National Trophy. An order has been placed with the agreed supplier for the provision of 132 National Trophies (22 x 6 years). Delivery is expected before the end of October 2005.
3. ANBC Badges. An order has been placed with the supplier to replenish stocks of A.N.B.C. Badges and A.N.B.C. National Judges' Badges. Many thanks to Bruce Bradford for his assistance with this and for remembering where to find the previous supplier.
